Conditions for Affiliate Membership

Eligible persons may be elected to Affiliate of the WA Branch in accordance with and subject to the Rules of The Returned & Services League of Australia, as per By-Law 4.

- No person shall be admitted as an Affiliate of the Sub-Branch if they are eligible for Service Membership of the League.
- Applicants must be 18 years of age or older.
- Any person, being eligible for Affiliate Membership, may apply for Affiliate Membership by lodging with the Sub-Branch an Application for Affiliate Membership alongside documentary evidence in respect to their claim for membership.
- Subject to the Rules of the League & to any directions given by the State Congress restricting their rights, privileges or duties, Affiliates shall have the equivalent social rights & privileges as Service Members within their Sub-Branch.
- Affiliates do not have equivalent privileges as Service Members to serve on a Sub-Branches Executive Committee, as per By-Law 4.8
- Affiliates are entitled to attend all Sub-Branch meetings, however are entitled to vote on issues relevant to that Sub-Branch only.
- Affiliates are not entitled to receive welfare (financial) support as provided to Service Members.
